THE MAJORITY OF THE ORGANIZATION'S SCHOLARS START THEIR HIGHER EDUCATION AT A COMMUNITY COLLEGE AND THE ORGANIZATION CURRENTLY OPERATES ON 5 PARTNER COMMUNITY COLLEGE CAMPUSES IN SANTA CLARA.
