Their day-in, day-out, step-by-step hard work propels our scholars toward the lives they dream of, filled with opportunity, success, and happiness. Briana and Jennifer, whose stories are shared later in this report, are shining examples of how our scholars are assuring their tomorrows.

Last year, Pivotal scholars achieved historic outcomes with high school graduation, college matriculation, and bachelor’s degree attainment rates far exceeding the state and national averages for young people from foster care. And because we connect scholars to other critical resources such as housing and mental health care, they are avoiding the fate of so many other foster youth who experience staggering rates of homelessness, incarceration, and substance addiction upon aging out of the system.

We also made significant strides in our career readiness programs. Pivotal corporate partners hosted Career Days where our scholars explore potential career paths, build professional development skills, and identify internship and job opportunities. Of course, it is a major accomplishment to earn a college degree. But equally important, we want to ensure our scholars successfully launch and persist in their careers.

One of the most exciting developments of the year came from Pivotal donor Louise de Putron. As part of her incredible \$1 million commitment over three years, she has designated \$50,000 per year to create a mental health fund so scholars can access therapy and other services they need.

As we look to the future, we cannot help but recognize the tumultuous times we currently face. Despite this, Pivotal is moving full steam ahead. We are building on our successes and embarking on a new strategic plan that I look forward to sharing with you later this year. Our newly updated core values of **collaboration, impact, integrity, compassion, and commitment** are guiding this work as we chart a course for the future to ensure our long-term sustainability and impact.





THE REALITY FOR FOSTER YOUTH

For the more than 365,000 young people in foster care in the United States, the statistics are sobering: they face higher rates of homelessness, unemployment, and academic disruption than their peers. But behind every number is a young person with dreams, talents, and the drive to succeed if given the chance. At Pivotal, we're changing the narrative by listening to our scholars, investing in their goals, and building pathways to lasting stability.

We know that when foster youth thrive, communities do too.

FOSTER YOUTH

NATIONALLY:

- 17% of foster youth experience homelessness by age 21.
- By age 17, 30% experience incarceration and 24% are referred for substance abuse assessment or counseling.
- By age 21, 45% reported not having full- or part-time employment.

FOSTER YOUTH

IN CALIFORNIA:

- In the 2024-25 school year, 31% of foster youth in California were chronically absent compared to 17% of all students.
- 44% of foster youth in California report experiencing some level of justice system involvement before the age of 17.
- In the 2023-24 school year, 25% of foster youth in California dropped out of high school, as compared to 9% of non-foster students.
- Foster youth change placements an average of 1.5x per year before the age of 18.



CHANGING THE NARRATIVE



MEET BRIANA



**“Sometimes success
feels like staying afloat.”**

That's how Pivotal scholar Briana describes her life journey. Briana transitioned out of foster care at 18, two years before the Extended Foster Care bill passed. This California law extends services to foster youth beyond their 18th birthday, but it passed long after Briana could take advantage of it. With the help of a Pivotal scholarship, she had started at Dominican University six months earlier, but when the dorms closed during the holiday break, she had just turned 18 and was on her own. With nowhere to go, she became unhoused.

She was lost and distraught and still dealing with mental health issues stemming from the trauma she had experienced when she was younger. She reached out to one of her sisters who came without hesitation to help gather her belongings.

While she was still unsure of her future and sleeping on friends' couches, she got an email from Pivotal about a part-time job opportunity at the Hub - a youth-led and youth-organized community center dedicated to supporting current and former foster youth. She applied and eventually became one of ten founding members of the organization. She buried herself in her work, setting aside her education to

focus on raising her newborn daughter. Unfortunately, she was also grappling with a turbulent and abusive relationship with her daughter's father. When her daughter turned one, she made the decision to leave her partner, not only to protect herself and her child, but to create a healthier future for them both. “I wanted to break the cycle of abuse and foster care.”

She worked at the Hub for 12 years, quickly discovering that she had a passion to work with underserved youth. She found herself consistently talking to these young people about the importance of education. “I realized that I had to point that finger back at myself and work to finish my college degree.”

Briana re-enrolled in community college, but she was still navigating mental health issues. Her severe PTSD and frequent panic attacks eventually led to agoraphobia, an anxiety disorder that made it difficult for her to go anywhere on her own. By this time, she was working regularly with a Pivotal coach, Sarah, and when she explained that she was terrified to go on campus, Sarah immediately offered to accompany her and help ease back into that environment.



“Sarah helped me feel like I belonged there. She’s legally blind and works with a guide dog named Future. Her steady presence and the way she navigated the world with confidence made me feel less alone in my own challenges. It also helped me see that using a service animal could be empowering. I had been considering a service dog and meeting Future helped solidify that decision.”

That’s when Ariel entered her life, a service dog from Operation Freedom Paws who became a vital part of her healing journey. Ariel helped her gain confidence, manage her PTSD and panic attacks, return to school, and stay on top of her coursework. “Ariel really helped me to live life,” she says. Sarah also helped her realize that she was ready to take the next step and transfer to a four-year university.

“I don’t know where I would be without Sarah. When I got the acceptance to San Jose State University, Sarah was the first person I called – even before my fiancé! If it wasn’t for her support, I don’t think I could have made it happen.”

Briana graduated from West Valley College and transferred to San Jose State University the

following fall to work on a bachelor’s degree in psychology.

“I’ve learned that I just have to keep at it, keep chiseling away. I’m proud of everything I’ve accomplished – my graduation, but also the work I’ve done at the Hub, and being part of that process to help other foster youth.”

Briana is motivated by her daughter, now ten years old, but she says she’s also learned to become her own motivator. “I want to do good for myself, so I can do good for others. I want to eventually start my own nonprofit, working in mental health and animal therapy. Far too few foster youth have access to mental health services, and I want to do all I can to change that. I can’t wait to see where life takes me next.”

“Sometimes success feels like just staying afloat.” But Briana is finally beyond treading water. It may not always be smooth sailing, but she’s charting new waters now, with her daughter, her fiancé, her faithful companion, Ariel, and of course, her Pivotal coach by her side. The world has opened up to her, and new destinations await!

IN HER OWN WORDS: JENNIFER



Being from foster care is a lot. For me, the challenges I faced while in the system knocked me off my educational path. I struggled with substance abuse, homelessness, and incarceration. I didn't graduate from high school, and I never really knew how to get to college. Growing up, it was never something that I thought I could do. I just assumed it wasn't for me.

I eventually got my GED and decided to go to San Jose City College to get certified as an alcohol and drug counselor. It was there that I met my Pivotal coach Kayla, who showed me that I had other options.

I was just going to get my certificate and get out of there, but Kayla really motivated me to go further. She helped me gain confidence in myself and the things I could do. Still, when she suggested that I consider transferring to San Jose State University, I was skeptical. I had no idea how to do that, and I certainly didn't think I could afford it. Kayla insisted that I could. She helped me get a Pivotal scholarship, find other financial aid, and keep going to get the credits I needed to transfer. She believed that I could do it, and I did! I graduated with honors and transferred to San Jose State where I earned my degree in sociology.

Once again, I didn't think I would continue my education beyond my bachelor's degree but with Kayla's encouragement, I applied to UC Berkeley's Social Work program and got accepted! I've been working full-time, and this is a full-time program so

it's going to be a big change. But this is my dream school and my dream career so it's a leap of faith.

I really thought my life was too far gone to make anything of it – I had made such a mess, and I didn't think there was any coming back from that. But in just the last few years, I've done so much and made so many positive changes.

What drives me is my passion for helping others in my community. Not too many people who have been through what I have been through have the opportunities that I've had, and I want them to know that with the right motivation and drive, they can have the things they want.

If it wasn't for Kayla believing in me when I didn't believe in myself, I wouldn't be where I am today.

I'd have gotten my certificate and become an alcohol and drug counselor, which would have been fine. Being an alcohol and drug counselor was a goal for me. But becoming a social worker is a dream and Kayla and Pivotal helped me see that this dream could be my reality.

I don't know what the next chapter in my life will look like. I just know that I have this opportunity and that I want to make the most of it. I am proud of everything I've accomplished and I'm grateful to people like Kayla and programs like Pivotal's that helped me along the way.

FROM POTENTIAL TO PROFESSIONAL

We know that with the right support and resources, Pivotal scholars can set the bar higher than they imagined and achieve their dreams. But it can be hard for young people from foster care to know what career options they have. To showcase some of the professional paths that might be open to our scholars, we reached out to our corporate partners who immediately stepped up to host a series of Pivotal Career Days.

Comerica, Harmonic, Equinix, and Excite Credit Union invited Pivotal scholars to visit their corporate offices, tour their facilities, and network with professionals to learn what their educational and professional paths looked like.



Attending Pivotal's Career Day with Comerica was a great summer experience. We got to see how different parts of the bank work, like marketing and small business partnerships. Hearing from employees who started as tellers and worked their way up was really inspiring.

THE WEIGHT OF TRAUMA

Foster youth carry a lot on their shoulders. Trauma, instability, and loss coupled with lack of consistent support and frequent school changes often lead to mental health challenges like anxiety, PTSD, and social isolation. It's also common for young people in and from foster care to cope with their trauma by engaging in high-risk behaviors such as violence, substance use, and delinquencies and to experience higher levels of unemployment, homelessness, and incarceration.

When Pivotal Dream Maker Circle Donor, Louise de Putron, heard about these challenges, she wanted to help. Her generous multi-year gift allowed us to launch **Pivotal's Mental Health Fund** to connect our scholars to the resources they need when they need it most. Louise's gift also includes support for our scholarship and coaching programs.

"Young people from foster care face unique and often invisible challenges that require more than just financial aid," said Louise. "With this gift, I hope to not only open doors to education, but also to help build a foundation of mental wellness that allows young people to truly succeed."

This year, we've begun a program to help scholars access therapy, assessments, specialized treatment, and other mental health services. Led by Pivotal's Director of Coaching Programs, Savonna Stender-Bondesson, LCSW, this initiative is helping our scholars take real steps toward healing.

"Many of our scholars require ongoing, long-term therapy to help them assess and address their mental health needs and heal from trauma," says

Savonna. "But finding consistent, affordable care isn't easy. That's where our coaches come in."

For scholars still in care, County-provided mental health services are available until age 21. But once a scholar ages out, their options are limited. Ironically, as they navigate adulthood, this is the time when they're more likely to benefit from long-term therapy and reflection.

The Pivotal Mental Health Fund works to help these scholars find the support they need. We are building partnerships with local organizations and mental health practitioners, many of whom have deep experience working with foster youth. The Mental Health Fund is directly paying for, or supplementing, the cost of these services to help Pivotal scholars overcome the mental health barriers preventing them from achieving their goals. Our scholars have received multiple forms of therapy, including ADHD assessments, substance-use counseling, and short-term intensive treatments, to address the complexity of their individual needs. In addition, our coaches are receiving additional Mental Health First Aid training and building new processes to identify scholars who most need this type of support.

We're incredibly grateful to Louise for her generosity and to Savonna and our incredible coaching team who are bringing this vision to life and proving what's possible when compassion, expertise, and community come together. Together, we're addressing one of the most urgent needs facing foster youth today, ensuring every scholar has access to the healing they deserve.


